Subscriptions	Subscriptions allow users to access Circles. Subscribers include Investigators, Team Members and Service Providers.	\$35 per Month
Cases	A Case comprises a single Observational Protocol and all associated longitudinal data captured against that O.P. for a single Data Subject.	\$5 each
Enterprise Circle	The first Circle for an Enterprise Client. Includes normal Circle design; encoding of roles, permissions, and other customization settings; patient consent forms; onboarding and training of initial Investigators.	\$3,500
Supplemental Circle	All Circles for an Enterprise Client after the Initial Enterprise Circle. The first and all subsequent Circles for a Small Provider.	\$500
Clinical and/or Scientific Service and	Any service and support involving RegenMed clinical or scientific expertise. Examples include Report preparation, advanced Circle design, coordination with medical statisticians, legal counsel, and other third-party exports. (Third-	\$150/hour

Support	party experts are for the account of the Client.)	
Technical Support	Data migration, integration with other platforms, non-standard language translation, Circle modifications, other technical support.	\$75/hour
SMS Patient Messaging	Optional service for SMS patient follow-up reminders.	Country dependent. See schedule <u>here</u> .

PAYMENT TERMS

Taxes	All VAT, sales, and other taxes are for the account of the Client.
Bank Fees	All wire charges, currency conversion and other bank fees are payable 50% by RegenMed and 50% by Client.
Pre-Authorization	All Circle and other charges are to be paid through an authorized credit or debit card, or automatic bank debit authorization.
Billing Cycle	Case charges accrued through the end of each calendar month are payable within the first ten days of the following month. Subscription charges are payable monthly in advance. Additional Circle and Support Hour charges are payable upon the execution of the relevant Statement of Work. Initial Enterprise Circle charges are payable 50% upon execution of the Master Services Agreement and 50% thirty days thereafter.

Cancellation	Client may cancel one or more inCytes TM Licenses at any time upon thirty days' written notice. All Circle and other charges incurred through the expiration of such thirty-day notice period remain payable.
